# Consideration of Online NOC applications

### Case no. 385

(Mrs. Chandra Kant Verma, B-7 Extn./21 Safdarjung Enclave, New Delhi)

After perusal of the application, it was decided to recommend grant of NOC in this case for construction of Basement+Stilt+GF+3 floors with the total height of the building restricted to 18.00 mtrs (including mumty parapet, water-storage, lift machine room etc.) B-7Extn./21 Safdarjung Enclave, New Delhi; with floor area Stilt=GF=FF=SF=74.97sqm, TF=68.94sqm and Basement = 74.97 sqm with depth=3.20mtrs. The NOC is recommended to be granted with the terms and conditions mentioned in report of Competent Authority, Delhi. The applicant should follow the local building bye-laws while constructing the building.

## Case no. 386

(Mr. Krishan Kumar & Sh. Suresh Kumar, D-56, Masjid Moth, Panchsheel Enclave, New Delhi)

After perusal of the application, it was decided to **recommend** grant of NOC in this case for Addition/alteration on GF+2 floors on the existing Basement+GF+2 floors with the
