The case was recommended for construction of Basement+Stilt+GF+3 Floors of residential building with the total height of 18mt. (including mumty, parapet, lift room, water-storage tank etc.) at plot no.16/1,2 and 4, ward no.1 situated at kh. no. 1151/3 in Abadi of Lal Dora of village Mehrauli; with floor area of Stilt=G.F.=F.F.=S.F.=T.F.=160.97 sqmt. & Basement area: 113.89 sqmt. with depth- 3.27mt. The NOC is recommended to be granted with the terms and conditions mentioned in the report of CA, Delhi.




